1. Purpose

The Account Transfer Discount Contract of the Selective Rules and Rates aims to promote payment of electric charges through the transfer of funds from the account specified by the customer to the account of Kyushu Electric Power Co., Inc (hereinafter referred to as “KYEPCO”). This transfer (hereinafter referred to as “account transfer”) is carried out through financial institutions designated by KYEPCO and contributes to operating cost reductions at and the effective business operation of KYEPCO.

2. Approval and Revision of the Selective Rules and Rates

- (1) The Account Transfer Discount Contract of the Selective Rules and Rates has been submitted for approval to the Minister of Economy, Trade and Industry, pursuant to Article 19.7 of the Electricity Utilities Industry Law.
- (2) KYEPCO may revise the Account Transfer Discount Contract upon submitting notification for approval to the Minister of Economy, Trade and Industry. Upon such revision, the electric tariff and other supply conditions are governed by such revised Account Transfer Discount Contract.
- (3) KYEPCO shall revise the Account Transfer Discount Contract whenever revision is made to the Rules and Rates for Electric Service (submitted on February 14, 2007, hereinafter referred to as the “Rules and Rates”).

3. Application

This contract is applicable to a customer who receives electricity under Residential Lighting or Low Voltage Power set forth in the Rules and Rates or Lighting by Time-of-Use, Lighting by Season & Time-of-Use, High-Load Factor Lighting, Low Voltage Power by Season & Time-of-Use, Nighttime Power or Nighttime Power II of the Selective Rules and Rates, pays electric charges monthly through account transfer based on the meter-rate system, and requests the application thereof.

However, this contract does not apply to customers who are notified of an account transfer and other results by mail every month or whose electric charges under multiple supply contracts are paid through collective account transfers.

4. Conclusion of the Contract

The Account Transfer Discount Contract is concluded when the financial institution specified by the customer completes the prescribed procedure and KYEPCO accepts the customer’s application. In such event, KYEPCO notifies the customer of the conclusion of such contract.

5. Rates

(1) If the electric charge from the previous month has been deducted from the customer’s account on the transfer day that KYEPCO specified as the first day for account transfer (hereinafter referred to as “first transfer day”), the electric charge for the month shall be calculated by deducing the amount of transfer discount from the net charge for prompt payment determined for Residential Lighting, Low Voltage Power, Lighting by Time-of-Use, Lighting by Season & Time-of-Use, High-Load Factor Lighting, Low Voltage Power by Season & Time-of-Use, Nighttime Power or Nighttime Power II, and the amount thus obtained shall be deemed the net charge for prompt payment.

However, for a customer in an area designated by KYEPCO and when the electric charge is billed after the following meter reading day, the provision above shall apply if the electric charge from two months before has been paid on the first transfer day.

(2) The account transfer discount in (1) above shall not apply to the electric charge for the period from the meter reading day immediately before the termination of the supply contract to the day before such termination.

6. Discontinuance of the Account Transfer Discount Contract

(1) If the customer wishes to discontinue the Account Transfer Discount Contract, the customer is required to notify KYEPCO in advance of the date supply service is to be discontinued.

(2) The Account Transfer Discount Contract shall terminate on the date of discontinuance notified by the customer, except for the following cases:

(A) If the customer discontinued the supply contract under Residential Lighting, Low Voltage Power, Lighting by Time-of-Use, Lighting by Season & Time-of-Use, High-Load Factor Lighting, Low Voltage Power by Season & Time-of-Use, Nighttime Power or Nighttime Power II, the Account Transfer Discount Contract shall be deemed terminated on the day the contract is terminated.

(B) If KYEPCO receives the customer’s notice of discontinuance after the date specified for such discontinuance, the Account Transfer Discount Contract shall be deemed terminated on the day KYEPCO received such notice.

7. Others

Other items not covered herein shall be as defined in the Rules and Rates, or the Selective Rules and Rates concerning Lighting by Time-of-Use, Lighting by Season & Time-of-Use, High-Load Factor

Lighting, Low Voltage Power by Season & Time-of-Use, Nighttime Power or Nighttime Power II.

SUPPLEMENTARY PROVISIONS

Enforcement Date

The Account Transfer Discount Contract of the Selective Rules and Rates shall be implemented on and after April 1, 2007.
